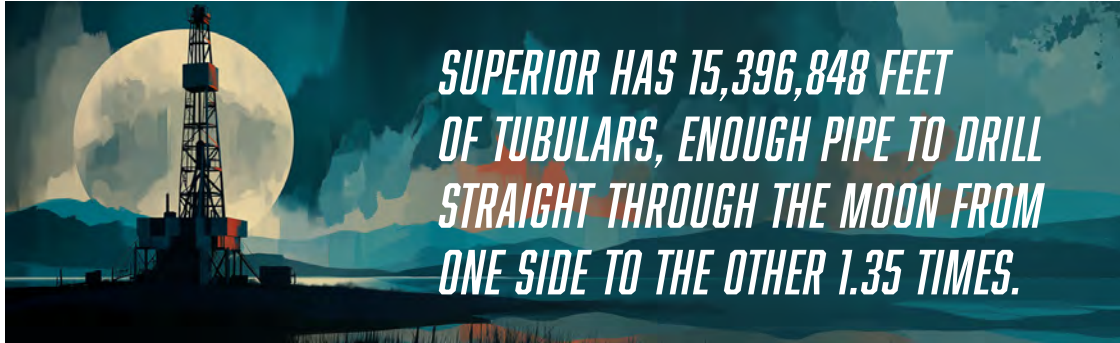

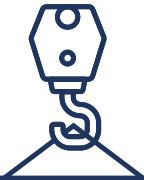
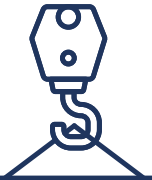


# ***FASTR<sup>®</sup> 3MM LB SYSTEM SETS NEW OFFSHORE INDUSTRY RECORD***

This system represents the highest-capacity purpose-built landing string ever manufactured and was specifically designed to meet the extreme demands of ultra-deepwater exploration.



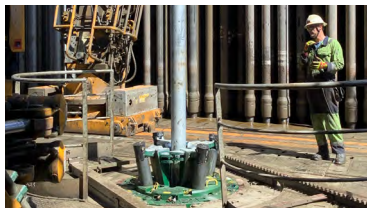
The operation recorded an unprecedented 2.849 million pounds on the weight indicator and a 2.639-million-pound hook load. These figures highlight the strength of our engineering and the precision of our execution. 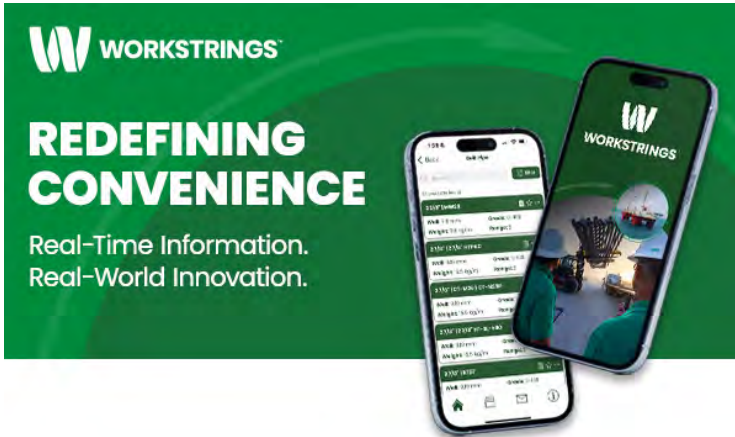

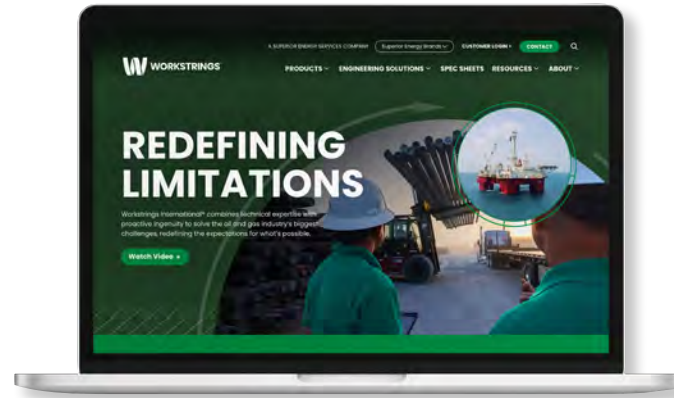

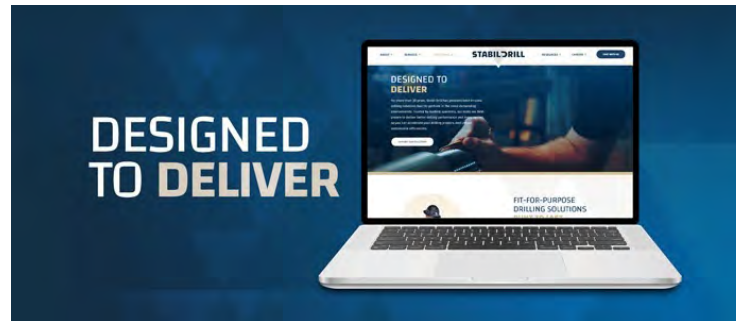

# RECORD-SETTING THREE-ZONE MST INSTALLATION

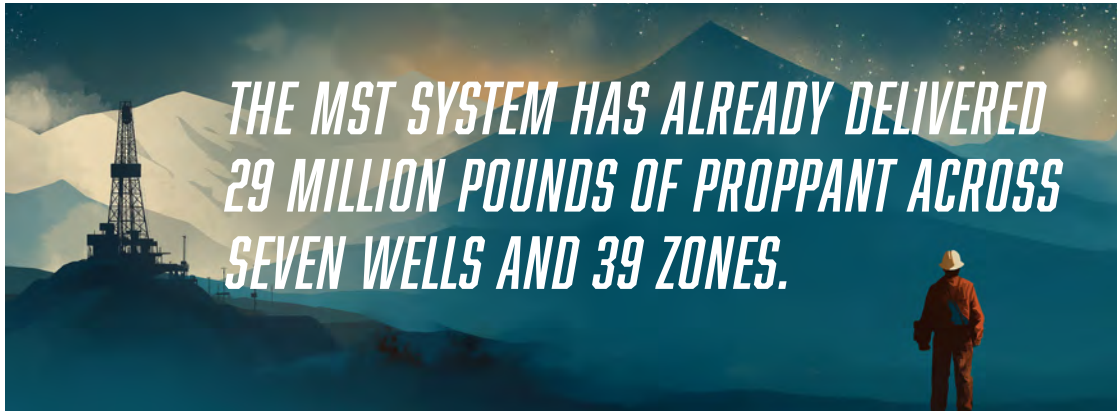
Superior Completion Services achieved a groundbreaking three-zone MST installation in a high-profile offshore well, setting a new benchmark in deepwater completions. At nearly 28,000 feet underground, this project required the delivery of more than 430,000 pounds of proppant across three zones in an environment with tight spacing and sharp turns.

The team overcame significant technical challenges through custom-engineered solutions, clear communication, and precise execution. From the initial order in May 2024 to equipment deployment in January 2025, every step was marked by collaboration and excellence. This milestone builds on the broader success of the MST system, which has already delivered 29 million pounds of proppant across seven wells and 39 zones. By saving approximately three days per zone, the system allows customers to complete wells more quickly and efficiently, reducing costs and accelerating production. It is a technology that transforms the economics of completions and reaffirms Superior's leadership in downhole innovation.

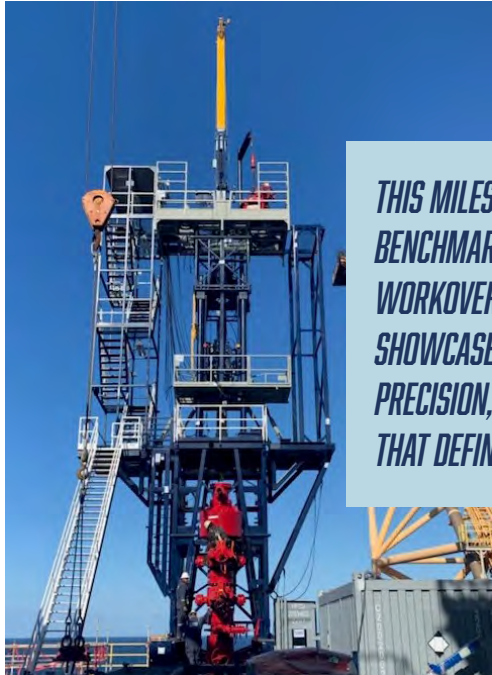

### ISS Sets Deepwater Record with Rig 46

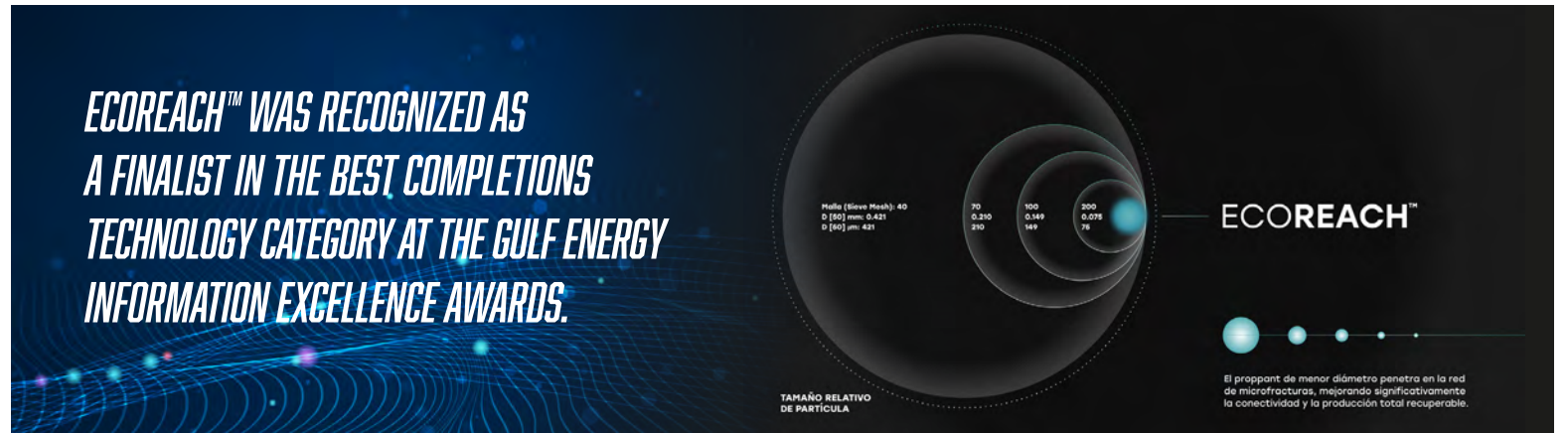
International Snubbing Services (ISS) achieved an industry first by completing a new drill using a hydraulic workover unit from a floating facility.

Operating in 5,000 feet of water, the ISS team used its 600K capacity Rig 46, designed and built entirely in-house, to drill two 14½-inch holes and deploy electric submersible pumps that restored production in an aging offshore field.

Highly mobile and efficient, Rig 46 can operate from any floating facility, offering operators a cost-effective alternative to traditional drilling rigs.

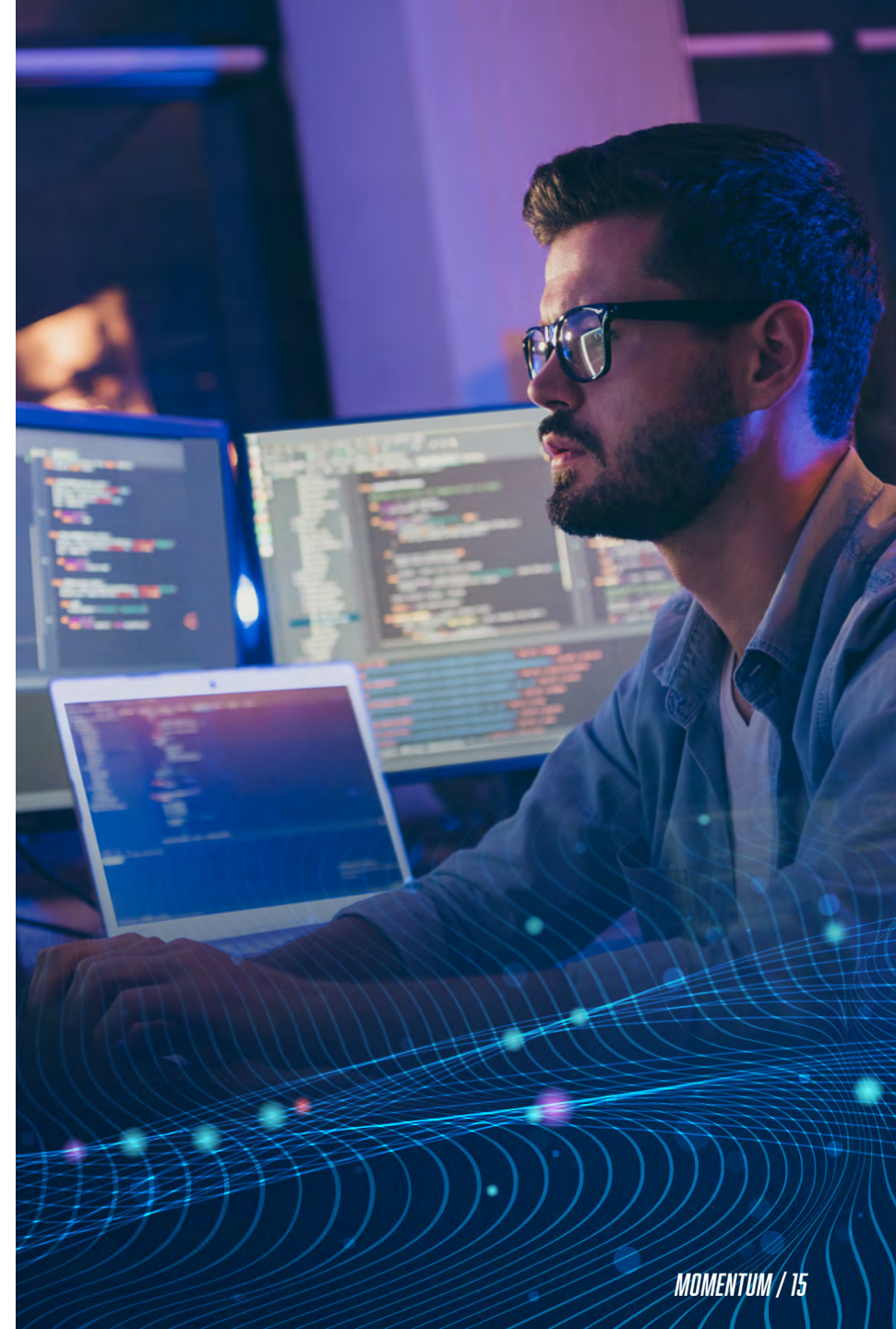
